

# REVFBC MUDBOWL LIABILITY RELEASE WAIVER

## Authorization and Consent of Parent or Legal Guardians for Emergency Medical Aid

I do hereby state that I have legal custody of the aforementioned Minor. I grant my authorization and consent for FBC to administer general first aid treatment for any minor injuries or illnesses experienced by the Minor. If the injury or illness is life-threatening or in need of emergency treatment, I authorize FBC to summon any and all professional emergency personnel to attend, transport, and treat the minor and to issue consent for any X-ray, anesthetic, blood transfusion, medication, or other medical diagnoses, treatment, or hospital care deemed advisable by, and to be rendered under the general supervision of, any licensed physician, surgeon, dentist, hospital, or other medical professional or institution duly licensed to practice in the state in which such treatment is to occur. I agree to assume financial responsibility for all expenses of such care. It is understood that this authorization is given in advance of any such medical treatment, but is given to provide authority and power on the part of FBC in the exercise best judgment upon the advice of any such medical or emergency personnel. This authorization is effective September 22, 2023.

## Release of Liability

Faith Bible Church (FBC) approves the student, parent and/or guardian participation in the 2023 mudbowl and its associated activities based upon the conditions set forth. I (parent/legal guardian, herein referred to as "releasor") voluntarily and knowingly executes this Release with the express intention of effecting the extinguishment of obligations as herein designated. The Releasor, with the intention of binding himself/herself, the Releasor's parents, spouse, heirs, legal representatives, and assigns, does hereby expressly release, relieve, discharge and agree to hold harmless FBC, its elders, deacons, interns, ministry leaders, representatives, and agents from any and all liability, claims, cost, demands, judgments, and executions, whether for personal injury, property damage, or otherwise, the Releasor, his/her heirs, legal representatives, or agent ever had, now has, or may have, whether known or unknown, against FBC, its elders, deacons, interns, ministry leaders, representatives, and agents, created by, arising out of, or in connection with the 2023 student ministries camp and its associated activities sponsored by FBC. Releasor hereby assumes full responsibility for the risk of bodily injury, death or property damage due to his/her participation in the 2023 mudbowl and its associated activities sponsored by FBC. Releasor expressly agrees that this release is intended to be as broad and inclusive as permitted by the laws of the State of California, and that if any portion is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect. Releasor understands and agrees that the voluntary consent to be bound by the terms and conditions set herein is a material consideration for FBC agreeing to approve the Releasor's participation in the 2023 mudbowl and its associated activities. By signing below, Releasor acknowledges that he/she has read and understands this Release of Liability. THE RELEASOR REPRESENTS AND WARRANTS THAT HE/SHE IS AT LEAST 18 YEARS OF AGE, AND HAS LEGAL AUTHORITY TO REPRESENT THE PERSON LISTED AT THE TOP OF THIS FORM.
